The Radnor Township Board of Trustees met on Tuesday, April 16, 2024 at 6:30 PM at the Radnor Community Center.

Trustee Boysel called the meeting to order and Trustee Weber led the Pledge of Allegiance.

Roll Call was taken as follows: Dan Boysel, aye, Dave Weber, aye, Cameron James, aye. Also present, Radnor Historical Museum representatives Ann Jones and Ken Fryman, RTFD employees Asst. Chief Bob Fish, Mike Foreman, Greg Butts, Steve Belville, and Dorian Ross, Todd Coonfare and Katarina Wheeland.

Trustee Weber motioned to approve the March 26, 2024 meeting minutes; Trustee James seconded. All ayes, motion carries 3-0.

Radnor Heritage Society & Historical Museum Report:

Ann Jones, president, notified the Board the Heritage Society raised all the funds for the ceiling project at the museum and requested permission from the Board to move forward with the work; the Board granted their permission. Ann asked the Board for \$420.00 to hang the lights at the museum; Trustee James motion to accept, Trustee Weber seconded, all ayes. The museum stated they are acquiring bids for painting.

Fire Department Report:

The Fire Department requested the HVAC unit have maintenance performed; Trustee Weber will set up a service call. The department queried about the electric for the house on Curtis Road; Trustee Boysel is taking care of it. The Board was presented with the run report for March and notified there are pests in the kitchen of the community room/fire house; Trustee Weber will contact an exterminator.

Maintenance Department Report:

Todd notified the Board the Freightliner truck is throwing a code and will be taken in for service. Additionally, after reviewing applications for employment, Todd has hired a new part time employee, Cameron Boes) to assist with trimming and mowing.

Board Report:

Trustee James procured a grant from the Delaware Public Health District for a water bottle filling station. He stated Genesis is waiting for approval of permits to begin work and has not received an update from DH Pace regarding the door work.


Trustee Weber reported soil has been moved to the east end of the cemetery from the former softball field/church field, it still needs to be finished and seeded.


