The Radnor Township Board of Trustees met on Monday, June 10, 2024 at 6:30 PM at the Radnor Community Center.

Trustee Boysel called the meeting to order and led the Pledge of Allegiance.

Roll Call was taken as follows: Dan Boysel, aye, Dave Weber, aye, Cameron James, aye. Also present, Radnor Township residents: Marty Hogan and Joe Thrush. RTFD employees Bob Fish, Mike Foreman, and Steve Belville, Todd Coonfare, and Katarina Wheeland.

Trustee Weber motioned to approve the May 28, 2024 meeting; Trustee Weber seconded. All ayes, motion carries 2-0.

Open Public Discussion:

Marty Hogan, resident on N. Sectionline Road, discussed the ongoing Canadian Thistle issue on the adjacent property; the Board verified Trustee James mowed the property along with fence in accordance with the fence law; since the land is agricultural, the Board cannot determine when the farmer harvests the middle of the field for hay; John VanGundy is current farmer contracted to bale the field and the Board suggested Mr. Hogan contact Mr. VanGundy regarding chemical spraying to deal with the weeds.

Joe Thrush, speaking on behalf of Radnor Youth Athletic Association, notified the Board RYAA is holding Radnor Day on Saturday, June 15, 2024 at the baseball fields.

Maintenance Department Report:

Todd stated the freightliner truck is back in service; he suggested the Board acquire quotes for trimming brush and trees along the property line at the township park.

Fire Department Report:

Eight interviews have been set up for the week; Assistant Chief Kelly has been working on a job description and will send the document to the Board for approval. The fire department has been in contact with the salesman at All American for Engine 431; working on getting in writing their claim to take care of everything that's gone wrong with the truck and all they have done on the truck while in service.

Trustees Report:

Trustee Boysel updated the Board on the Curtis Road FEMA House; siding has been taken off; the Board will do a Resolution for Bids to re-publish at the next meeting.

A resident has complained that the culvert at State Route 203 and Byers Road is going the wrong way; per Todd, it is a State of Ohio culvert and they are responsible.

Fiscal Officer Report:

The Board was presented with the Payment Listing for June 1 to June 10, 2024. Trustee James motioned to accept the Payment Register for June 1-10, 2024, Trustee Weber seconded; all ayes, motion carries 3-0.
