The Radnor Township Board of Trustees met on Monday, March 25, 2024 at 6:30 PM at the Radnor Community Center.

Trustee Boysel called the meeting to order and Trustee Weber led the Pledge of Allegiance.

Roll Call was taken as follows: Dan Boysel, aye, Dave Weber, aye, Cameron James, aye. Also present, Radnor Historical Museum representatives Ann Jones, Bill Thompson, Pam Zeirott, and Brent Zeirott, RYAA representatives Rich Latham and Carrie Hacker, Jenifer Way-Young from Delaware Public Health District, Joe Clase from Plan4Land, RTFD employees Asst. Chief Bob Fish, Shawn Kelly, Dorian Ross, Jordan Long, Steve Belville, Greg Butts, Ben Moder, Macie Stevens, and Mike Foreman, and Katarina Wheeland.

Trustee Weber motioned to approve the March 11, 2024 meeting minutes; Trustee James seconded. All ayes, motion carries 3-0.

Radnor Heritage Society & Historical Museum Report:

Ann Jones, president, provided the Board with a bid for ceiling work at the Museum for \$5,500; Ann stated the museum is able to pay \$3,000.00 and requests the Board pay the remaining \$2,500. The Board reiterated they are not paying for any more work to the Museum at this time. The Heritage Society requested permission to complete the ceiling work if they were able to pay for the project in full; the Board approved the work if it is at no cost to the Township.

Delaware Public Health District Report:

Jenifer Way-Young dispersed files from the Health Department to the Board their regarding smoke-free workplace program and a smoke free fact sheet.

Radnor Youth Athletic Association (RYAA) Report:

The dugout and field at the ball fields were vandalized within the past couple of days; damage was done to the dugouts, picnic tables, and cement blocks on the property. Delaware County Sheriff's Office was contacted; Trustee James provided a statement and a report was generated. The Township will file an insurance claim for the damage. RYAA requested permission to put up security cameras and a security light that they will provide for no cost to the Township; the Board approved their request for the security light but tabled the discussion of the cameras. Additionally, RYAA asked the Board to disperse the two 15 ft. dirt piles that were placed on the park property near the baseball fields as they are a hazard; Todd will contact Rich at the beginning of April to remedy the situation.

Park Strategic Plan Report:

Joe Clase updated the Board on future grant deadlines and requested the Board finalize what the Township would like to focus on.

Fire Department Report:

AED for the fire department and community center room have all been updated with new pads. Engine 431 is still out of service; it was repaired, came back to the department and more things were wrong so it was sent back for repairs.

Board Report:

Trustee James filled out the contact list for Genesis, the emergency monitoring company.

Trustee Weber reported dirt from the softball field at the Baptist Church was taken over to the township park for the baseball fields; he stated Ben Lehner is going to push excess dirt from church where parking lot will be at no charge.

Trustee Boysel stated the Zoning Committee met to look over zoning for the Township and will reconvene on April 1, 2024 at 6PM. Dan alerted the Board the investigating attorney is done with interviews with the fire department and plans to provide the Board with his report at the April 16, 2024 meeting.

Fiscal Officer Report:

The Board signed the February 2024 Bank Reconciliation.

The Board was presented with the Payment Listing for March 12 to March 25, 2024; Trustee James motioned to accept the Payment Register for March 12-25, 2024 except Check #16880 to Imperial Glass, Trustee Weber seconded; all ayes, motion carries 3-0.

The Board determined their next meeting would be moved to Tuesday, April 16, 2024 as Trustee Boysel will be unavailable on the 8th. At their meeting on the 16th, the Board will look at the old Buckeye Valley lease agreement with RYAA.

There being no further business, Trustee Boysel moved to adjourn and Trustee James seconded; all ayes, motion carries 3-0. The next regularly scheduled Board of Trustees meeting will be held on Tuesday, April 16, 2024 at 6:30 PM.
