Call to Order and Roll Call

The Radnor Township Board of Trustees met in regular session on Monday, August 25, 2025 at 8:00 AM at the Radnor Township Community Center, 4061 State Route 203, Radnor, Ohio. Chairperson Boysel called the meeting to order and the roll was called; attending were Trustees Dan Boysel and Dave Weber. Absent: Cameron James.

Approval of Minutes

Mr. Boysel moved and Mr. Weber seconded to approve the meeting minutes for July 28, 2025, August 1, 2025, August 7, 2025, and August 11, 2025. Vote: Boysel, aye; Weber, aye. Motion passed.

Public Input

- None.

Fire Department

- Annual hose inspection done, all hoses passed.
- E432 back in service; Tanker out of service for repairs/maintenance.
- Genesis estimate = \$800.00 to fix egress light.
- Interviews for part-time staff ongoing; will try to have recommendations by next meeting.
- Discussion regarding concrete quote; will likely have to bid out unless have job separated into two bids (front and back). Suggested waiting until spring.
- Request to raise on-call pay from \$50.00 to \$100.00 per night. Board asked for stats to be provided regarding coverage and overnight runs before making any decisions.

Road/Maintenance Department

- Doug Riedel, Delaware County Engineer's Office, was on site for the annual road tour following the close of meeting.
- Todd Coonfare discussed tree overhang issues on River Rd.; he received a quote from Fisher Tree Services for \$1,500.00/day to trim trees; however, he suggested waiting for now as other areas will likely need done per the school district.
- The disinterment in the cemetery has been scheduled and Todd is working with Snyder Funeral Home to coordinate. ~~Todd~~ ^{Dan} suggested the Board consider adding a "disinterment fee" to cemetery rates during the 2026 Reorganizational Meeting.

Board Report

- Mr. Boysel stated there is a Zoning Committee Meeting scheduled for Wednesday, August 28, 2025 at 4:00 PM.
- The Board was provided with Resolution #12-25; a resolution accepting the rates and amounts for 2026 as determined by the Delaware County Commissioner. Mr. Boysel moved and Mr. Weber seconded to accept Resolution #12-25. Vote: Boysel, aye; Weber, aye. Motion passed.
