## Minutes of the Radnor Township Board of Trustees

### Call to Order and Roll Call

The Radnor Township Board of Trustees met in regular session on Monday, February 10, 2025 at 6:30 PM at the Radnor Township Community Center, 4061 State Route 203, Radnor, Ohio. Chairperson Boysel called the meeting to order and the roll was called; attending were Trustees Dan Boysel, Dave Weber, and Cameron James.

## **Approval of Minutes**

Mr. Weber moved and Mr. James seconded to approve the minutes of the January 27, 2025 meeting. Vote: Boysel, aye; Weber, aye; James, aye. Motion passed.

## Public Input

- River Road has pot holes between Dildine Road and Radnor Road; a township resident has requested they be repaired. Mr. Weber will call the resident to discuss more in depth.

## Fire Department

- New Wi-Fi is up and running; the phone system is still awaiting service. The fire department computer is having issues with the updated Wi-Fi, Firefighter Ross suggested new desktop computer options and Chief Fish will purchase the new computer.

## Road/Maintenance Department

## Financials/Fiscal Officer

 Mr. Weber moved and Mr. James seconded to approve pending blanket certificates #17-2025 through #20-2025 and warrants detailed in payment listing detail report for February 1, 2025 through February 10, 2025.

#### Old Business

- Mr. James met with Mr. Michael Cavanaugh from Delaware County Prosecutor's Office regarding township policies and procedures. Mr. Cavanaugh is reviewing the document and will be in touch.
- Records request made by NBC4 regarding the investigation performed by Mr. David Riepenhoff in 2024 has been completed; Ms. Cleary from NBC4 has been sent the proper correspondence.
- The Board discussed the proposal from Buckeye Valley Local School District to purchase the property located at 4230 State Route 203, Radnor, also known as the township park and baseball fields. Mr. Boysel notified the public the proposal is a \$2.00 transfer fee and states the playground and baseball fields/buildings would remain for at least ten years; additionally, the flag pole and memorial items would remain on park property. Mr. James questioned what would happen to the playground and ball field structures after the ten years, as well as how does this plan benefit the township? Mr. Boysel briefly mentioned the capital improvement grant that has been award to Radnor Township for the park. The Board then opened discussion to the public to hear questions and concerns from Radnor Township residents, Radnor Girls Softball Association, and Radnor Youth Athletic Association. There was an overwhelming attendance at the meeting in favor of keeping the property in the jurisdiction of Radnor Township. Over twenty five individuals spoke to the Board regarding their opinions and hopes for the park, playground and ball fields to be kept as Radnor public property and not to allow BVLS to

purchase the land. There were zero public comments in support of selling the proposed property. The Board still plans to vote on the proposal at their regular meeting on Monday, February 24, 2025.

## **New Business**

- Mr. Weber motioned and Mr. Boysel seconded to accept Mrs. Pam Zeirott as Chairperson for the Wreaths Across America committee for Radnor Township. Mr. Weber stated Mrs. Zeirott did a great job in 2024 when Radnor Cemetery participated in Wreaths Across America for the first time; he remarked that it was akin to Memorial Day in Radnor Township.
