## Minutes of the Radnor Township Board of Trustees

January 11, 2021

Page 1

The Radnor Township Board of Trustees met on Monday, January 11, 2021 at 7:00 PM at the Radnor Community Center.

Those present were: Teresa Watkins, Dave Weber, Dan Boysel, Todd Coonfare, and Katarina Wheeland.

Katarina called the meeting to order and led the Pledge of Allegiance.

Minutes of the December 28, 2020 meeting were read. Dan moved to approve the December 28, 2020 meeting minutes and Dave seconded.

By Resolution #01-21, the following Reorganization Proposals are effective immediately: Dave will serve as Chairperson in 2021; Dan will be Vice Chairperson and meetings will be held the fourth Monday of each month at 7:00 PM at the Radnor Community Center. The Trustees discussed increasing wages across the board by 4% and giving overtime to Maintenance employees on Christmas Day and New Years Day. Cemetery Fees were updated to \$655.00 for opening and closings, as well as an increase of Non-resident Cemetery lots to \$1,800.00. Dan moved to accept the Resolution; Dave seconded; all ayes.

Todd informed the Board of Trustees that there were 22 funerals in the Radnor Cemetery in 2020 and a total of \$19,250.00 in sales of cemetery lots for the year.

Dave notified the Board that he has begun the process of leasing a new plow truck.

Dan presented the Board with Resolution No. 03-21 consenting to the Board of Commissioners of Delaware County granting an access easement to Cellco Partnership for vehicular access to the telecommunications tower located at 4095 SR 203. Dan moved to accept the Resolution, Dave seconded.

Teresa signed a policy provided to her by FEMA stating that the Township will not sell the property on Curtis Rd. and that we are not liable for damage to the property.


Teresa reported that she has obtained information regarding the purchase of an iPad for the Maintenance department. She stated the iPad needs cellular capabilities; therefore it was discussed that the purchase of the iPad occur through Verizon Wireless.

The Board of Trustees signed the bank reconciliation for December 2020.

The Board was presented with the 2021 Revenue and Appropriation Budget. Fiscal Year 2021 revenues are budgeted at \$935,973.73 and Fiscal Year 2021 appropriations are budgeted at \$2,205,500.00. Dan moved accept Resolution #02-21, the 2021 Revenue and Appropriation Budget; Dave seconded. All ayes.

The next Board of Trustees meeting will be Monday, January 25, 2021 at 7:00PM at the Radnor Township Community Center located at 4061 State Route 203.


There being no further business, Dan moved to adjourn and Dave seconded.




