Minutes of the Radnor Township Board of Trustees

The Radnor Township Board of Trustees met on Monday, August 22, 2022 at 7:00 PM at the Radnor Community Center.

Roll Call was taken as follows: Dan Boysel, aye; Dave Weber, aye; Teresa Watkins, aye. Also in attendance: Jenifer Way-Young, Josh Cross from Ohio Edison, Doug Riedel, Bob Fish, and Katarina Wheeland.

Dan called the meeting to order and Teresa led the Pledge of Allegiance.

Dan motioned to approve the August 8, 2022 meeting minutes as written. All ayes, motion carries 3-0.

Josh Cross notified the Board he is attending their meeting in order to touch base and answer any questions the Township has regarding Ohio Edison.

Jenifer Way-Young provided the Board with several fliers from Delaware Public Health District.

Doug Riedel from Delaware County Engineer's Office updated the Board on road work completed in the Township and stated the application deadline for OPWC project for 2023 will be late September or early October. The Board set a date for their annual Township Road Tour with Doug for September 27, 2022 at 9:00 AM.

Bob requested approval for staffing a third full time firefighter Monday through Sunday 7:30 AM to 4:30 PM; Dave motioned to approve the staffing, Teresa seconded, all ayes, motion carries 3-0. Bob notified the Board the fire department is approximately fifty percent done with completing background checks; the Board set a deadline of November 1, 2022 for all the firefighters to complete and agreed to pay for their time to complete equaling one hour of pay. Additionally, Bob stated TTM provided a quote to replace and install both heaters in the truck bay for \$5,150.00; Dave motioned to approve the work, Teresa seconded, all ayes, motion carries 3-0.

Dave alerted the Board to an oak tree on Gallant Road that is leaning toward the road, if the tree is the Township's, Dave requested permission to cut it down due to safety issue; Teresa and Dan both approved, motion carries 3-0. Dave also updated the Board that the salt barn project is set to begin Fall 2022.

Teresa notified the Board she is working with the Ashley Legion to replace the plaque at the baseball field. Teresa discussed setting a date for a solar meeting before the fall Township Newsletter is mailed out. She updated the Board on her discussion with Mr. Penkal from the Prosecutor's Office regarding spending ARP funds the Township received. Finally, Teresa stated the Delaware Historical Society is coming to tour the Radnor Cemetery on the 28th of August.


Dan asked the Board to submit anything of interest to him for the fall newsletter which he plans to send out mid-September.

The Board was presented with the Payment Listing and the Fund Status as of August 22, 2022. Dave motioned to approve the Payment Register for August 9-22, 2022, Dan seconded; all ayes, motion carries 3-0. The Board also signed the July 2022 Bank Reconciliation.


