## Minutes of the Radnor Township Board of Trustees

June 27, 2022

The Radnor Township Board of Trustees met on Monday, June 27, 2022 at 7:00 PM at the Radnor Community Center.

Roll Call was taken as follows: Dan Boysel, aye; Dave Weber, aye; Teresa Watkins, aye. Also in attendance: Shelia Hiddleson and Jenifer Way-Young from the Delaware Public Health District (DPHD), Randy Butts and Bob Fish (Radnor Township Fire Department), and Katarina Wheeland.

Dan called the meeting to order and Teresa led the Pledge of Allegiance.

Teresa motioned to approve the June 13, 2022 meeting minutes as written; Dan seconded the motion. All ayes, motion carries 3-0.

Shelia and Jenifer updated the Board on the DPHD, including their pool safety program, mosquito gathering/testing, quality of life survey, COVID-19 vaccine, latex paint drop off dates, and Scioto River clean up.

Randy and Bob reported to the Board the Fire Department was pleased with the turnout for their Hog Roast on Memorial Day.

Teresa notified the Board the appraisal for the property on Curtis Rd. came back higher than anticipated and it is more than FEMA would like to pay; we will still not be occurring any expense for the project and FEMA will negotiate with homeowner.

Dave updated the Board on the new road mower and stated it is impressive. Dave stated he spoke to township resident Willard Rice, who resides on Taylor Street, regarding the tile flooding his property; the Township is not responsible for the tile but Dave would like to jet the tiles on Township property nearby to see if that remedies the situation. Teresa motioned to approve the jetting, Dan seconded. All ayes, motion carries 3-0.

Dave and Dan stated they will not be able to attend the July 25, 2022 meeting as they are both out of town that week. Teresa moved to cancel the July 25, 2022 meeting due to schedule conflicts, Dave seconded; all ayes, motion carries 3-0.


