The Radnor Township Board of Trustees met on Monday, November 28, 2022 at 6:30 PM at the Radnor Community Center.

Trustee Weber immediately motioned to entered into executive session, Trustee Boysel seconded the motion; all ayes, motion carries 3-0. Roll Call was taken as follows: Dan Boysel, aye; Dave Weber, aye; Teresa Watkins, aye. The Board exited executive session at 7:00 PM.

Chairperson Boysel called the meeting to order and Trustee Watkins led the Pledge of Allegiance.

Additionally present: Jenifer Way-Young, Todd Coonfare, Randy Butts, Bob Fish and Katarina Wheeland.

Trustee Weber motioned to approve the November 14, 2022 meeting minutes with corrections; Trustee Watkins seconded. All ayes, motion carries 3-0.

Ms. Way-Young of the Delaware Public Health District provided information to the Board regarding the DPHD's new Health Commissioner, a flier concerning the measles outbreak in Franklin County, and a new Food Scrape Composting program.

Mr. Coonfare updated the Board on the township's maintenance department. The Board discussed three options for trading in and purchasing a new mower. Trustee Weber motioned to approve the purchase of a new mower quoted at \$12,899.39, to trade in the 2002 John Deere 1435, and to keep the 2016 mower as a backup. Trustee Boysel seconded the motion; all ayes, motion carries 3-0. Additionally, Trustee Weber motioned to accept Brad Williamson's offer to purchase the old mower for \$100.00, Trustee Watkins seconded; all ayes, motion carries 3-0.


Assistant Chief Fish notified the Board Mike's Roofing came to fix the pipes on the roof and will bill us \$850.00 for the repair.


Trustee Watkins reported she is investigating installing a fire suppression hood vent in the community room/fire department's kitchen estimated to be \$1,900.00. Additionally, she shared flooring samples with the Board for the carpet and vinyl flooring replacement.


Trustee Boysel stated the informational solar meeting that took place at the township community center had a very nice turnout of over thirty residents and was pleased with the presentation.
