The Radnor Township Board of Trustees met on Wednesday, July 12, 2023 at 6:30 PM at the Radnor Community Center.

Trustee Watkins called the meeting to order and Trustee Boysel led the Pledge of Allegiance.

Roll Call was taken as follows: Teresa Watkins, aye; Dave Weber, aye; Dan Boysel, aye. Also present, RTFD Chief Randy Butts, Assistant Chief Bob Fish, RTFD employee Dorian Ross, Todd Coonfare, and Katarina Wheeland.

Trustee Boysel motioned to approve the June 23, 2023 meeting minutes; Trustee Watkins Weber seconded. All ayes, motion carries 3-0.

Bob Fish notified the Board the new boat motor will be delivered that week.

Todd requested to move forward with replacing the trash cans at the Township Baseball Fields; the Board approved purchasing new trash bins. Todd stated the Cemetery has received \$18,400.00 for cemetery lots as of July 12, 2023. Todd asked permission to purchase a fan for the maintenance building.

The Board scheduled a road tour of Township roads for August 24, 2024 with Doug Riedel from the Delaware County Engineer's Office.

Trustee Boysel moved to accept the quote from TTM for a new furnace in the Historical Museum for \$4,100.00; Trustee Weber seconded. All ayes, motion carries 3-0.

The Board was presented with the Payment Listing, Receipt Detail, and the Fund Status as of July 12, 2023. Trustee Boysel motioned to approve the Payment Register for July 1-12, 2023, Trustee Weber seconded, all ayes, motion carries 3-0.


The Board was presented with, and signed, the June 2023 Bank Reconciliation.




