## Minutes of the Radnor Township Board of Trustees

July 24, 2023

The Radnor Township Board of Trustees met on Monday, July 24, 2023 at 6:30 PM at the Radnor Community Center.

Trustee Watkins called the meeting to order and Trustee Weber led the Pledge of Allegiance.

Roll Call was taken as follows: Teresa Watkins, aye; Dave Weber, aye; Dan Boysel, aye. Also present, RTFD Chief Randy Butts, Assistant Chief Bob Fish, RTFD employees Steve Belville, Brad Belville, Greg Butts, and Dorian Ross, Monica Conners, the Director of Economic Development for Delaware County, Doug Riedel from the Delaware County Engineer's Office, Todd Coonfare, and Katarina Wheeland.

Trustee Boysel motioned to approve the June 12, 2023 meeting minutes; Trustee Weber seconded. All ayes, motion carries 3-0.

Monica Conners introduced herself to the Board and provided a brief overview of her services for the township.

Todd Coonfare updated the Board on cleanup from the recent storm. The Board discussed the dugout roof at the baseball field due to the storm and decided to gather quotes for the repair; the damage to the dugout, as well as other structures at the park, are covered by insurance.

Doug Riedel presented the Board with the OPWC contract for N. Sectionline Road and the Board signed. Doug also stated the culvert repair on River Rd. north of Byers Rd. will finally begin; the work was originally quoted approximately two years ago. Additionally, Doug proposed Radnor Township come together with Thompson Township regarding zoning for ditch/pipes; the Board determined to keep current zoning.

Trustee Boysel discussed his meeting with Joe Clase of Plan4Land to put together a plan and suggested the Township hold a contributor's meeting in order to gain opinions from people willing to donate funds or supplies; the Board set meetings for the first Thursday of September and the first Thursday of October at 6:30 PM.

The Board requested a run summary for the first half of 2023 from Chief Butts.


Trustee Watkins signed the FEMA paperwork stating the asbestos check was completed at the Ramsey property on Curtis Rd. Teresa also notified the Board she called Emergency Plumbing to fix the kitchen sink as it was leaking; the cost for the repair was \$420.00 which the Board approved.


Former Township residents wrote to the Board requesting to purchase cemetery lots at the resident price despite no longer living in Radnor; the Board opted to keep the Cemetery Rules as is, and to not allow exceptions.

The Board was presented with Resolution #04-23, resolution of necessity for the fire levy renewal. Trustee Boysel motioned to accept Resolution #04-23, Trustee Weber seconded; all ayes, motion carries 3-0. The Board set a Special Meeting for Monday, August 7, 2023 at 8:00 PM to pass a resolution to proceed.

The Board was presented with the Payment Listing, Receipt Detail, and the Fund Status as of July 24, 2023. Trustee Boysel motioned to approve the Payment Register for July 13-24, 2023, Trustee Weber seconded; all ayes, motion carries 3-0.

There being no further business, Trustee Weber moved to adjourn and Trustee Boysel seconded; all ayes, motion carries 3-0. The next regularly scheduled Board of Trustees meeting will be held on Monday, August 14, 2023 at 6:30 PM
