Minutes of the Radnor Township Board of Trustees

The Radnor Township Board of Trustees met on Monday, June 12, 2023 at 6:30 PM at the Radnor Community Center.

Trustee Watkins called the meeting to order and Trustee ^{Weber}Boysel led the Pledge of Allegiance.

Roll Call was taken as follows: Teresa Watkins, aye; Dave Weber, aye; Dan Boysel, absent. Also present, Radnor Township resident Marty Hogan, Assistant Chief Bob Fish, RTFD employees Brad Belville and Dorian Ross, Todd Coonfare, and Katarina Wheeland.

Trustee Weber motioned to approve the May 22, 2023 meeting minutes; Trustee Watkins seconded. All ayes, motion carries 2-0.

Marty Hogan, Radnor Township resident on N. Section Line Rd., requested an update on the progress of destroying the Canadian Thistle on the neighboring property. The Board stated they are prepared to sign a resolution tonight and mail a certified letter to the property owner tomorrow.

Assistant Fire Chief Fish stated the department received their new air compressor and it is functional.


Todd Coonfare stated the maintenance department has received several donations of used oil, however, they need more totes to store the oil. He mentioned the backflow valve at the Township baseball fields was recently tested and passed inspection. Todd informed the Board the trees located on the fence line for the big baseball field have been cleaned up and will need more maintenance done in fall or winter. Todd notified the Board the trees on River Road and Hodges Road will likely need trimmed this summer before school resumes in August. Additionally, Todd said the Historical Museum will need a new furnace; Teresa offered to call TTM to get a quote for a small hanging propane furnace.


The Board was presented with Resolution #03-23 regarding the noxious weeds growing on Parcel No: 602-460-01-078-002. Trustee Weber motioned to accept Resolution #03-23, Trustee Watkins seconded; all ayes, motion carries 2-0.

The Board was presented with the Payment Listing and the Fund Status as of June 12, 2023. Trustee Weber motioned to approve the Payment Register for May 1-12, 2023, Trustee Watkins seconded; all ayes, motion carries 2-0.

There being no further business, Trustee Weber moved to adjourn and Trustee Watkins seconded; all ayes, motion carries 2-0. The next regularly scheduled Board of Trustees meeting will be held on Monday, June 12, 2023 at 6:30 PM.


