The Radnor Township Board of Trustees met on Monday, November 13, 2023 at 6:30 PM at the Radnor Community Center.

Trustee Weber called the meeting to order and Trustee Boysel led the Pledge of Allegiance.

Roll Call was taken as follows: Teresa Watkins, absent; Dave Weber, aye; Dan Boysel, aye. Also present, RTFD Asst. Chief Fish, RTFD employees Steve Belville, Brad Belville, Ben Moder, Dorian Ross, and Jordan Long, and Katarina Wheeland.

Trustee Boysel motioned to approve the October 23, 2023 meeting minutes; Trustee Weber seconded. All ayes, motion carries 2-0.

Asst. Chief Fish requested acquiring DelCo Water for the Fire Department/Community Room kitchen; the Board suggested trying a water softener first, Trustee Weber will contact Peacock Water.

The Radnor Township Fire Department provided the Board with a run update for October 2023; they stated the department has been on 159 calls since January 1, 2023 and in the past month, they had 2 EMS runs in the early morning before normal working hours that could not be run due to staffing.

RTFD employees presented the Board with two documents regarding safety issues on two different runs causing concerns for safety and leading to issues with staffing the department; the first document discussed the barn fire incident from over a year ago that is still not dealt with; the second dealt with documenting internal personnel issues requested by Chief Butts that have just been swept under the table.

Trustee Weber notified the Board he met with a glazer who can finish the window project at the township historical museum; the quote totaled \$1757.50 plus painting costs; Trustee Boysel motioned to proceed, Trustee Weber seconded; all aye, motion carries 2-0.

Trustee Weber alerted the Board that ~~17,000~~^{1,700} gallons worth of used oil that was being stored outside of the maintenance department building was removed due to storage safety concerns at no cost to the township. Therefore, not having access to used oil, Trustee Weber motioned the Township have an HVAC company install an overhead propane heater in the historical museum at the cost of \$4,500.00, Trustee Boysel seconded; all ayes, motion carries 2-0.


The Board signed the October 2023 Bank Reconciliation.


