The Radnor Township Board of Trustees met on Monday, September 11, 2023 at 6:30 PM at the Radnor Community Center.

Trustee Watkins called the meeting to order and Trustee Boysel led the Pledge of Allegiance.

Roll Call was taken as follows: Teresa Watkins, aye; Dave Weber, aye; Dan Boysel, aye. Also present, RTFD Assistant Chief Bob Fish, RTFD employee Steve Belville, Alex McCarthy from Delaware County EMA, Todd Coonfare, and Katarina Wheeland.

Trustee Boysel motioned to approve the August 28, 2023 meeting minutes and the August 28, 2023 road tour minutes; Trustee Weber seconded. All ayes, motion carries 3-0.

The Radnor Township Fire Department requested the Township acquire a dumpster as the trash bins are typically overly full; Trustee Weber will call Rumpke to inquire about service. Bob alerted the Board that the blacktop in the parking lot of the Fire Department and Community Center would be sealed on September 15-16th.

Alex McCarthy notified the Board the Curtis Road property is closing on Wednesday, September 13, 2023; the Board approved check #16503 for Northwest Title to allow Mr. McCarthy to take the payment to the closing.

Trustee Boysel notified the Board of the Delaware County Township Association meeting will be held on Saturday, September 16th at the Delaware County Fairgrounds. Dan suggested moving the strategic planning meeting for the Township park to October 12, 2023 to allow more time to prepare.

Trustee Weber reported there are several trees Buckeye Valley transportation has requested the Township trim due to busses hitting limbs.

Trustee Watkins stated the new appliances for the kitchen in the community room will be delivered on September 19, 2023.

The Board signed the August 2023 Bank Reconciliation.




