## Minutes of the Radnor Township Board of Trustees

December 23, 2024

The Radnor Township Board of Trustees met on Monday, December 23, 2024 at 8:00 AM at the Radnor Community Center.

Trustee Weber called the meeting to order and led the Pledge of Allegiance.

Roll Call was taken as follows: Dan Boysel, absent, Dave Weber, aye, Cameron James, absent. Also present: Jenifer Way-Young from Delaware Public Health District, RTFD employees Bob Fish, Shawn Kelly, Mike Foreman, and Steve Belville, and Fiscal Officer Katarina Wheeland.

Trustee James motioned to approve the December 9, 2024 meeting minutes; Trustee Weber seconded. All ayes, motion carries 2-0.

### Community Report:

Jenifer Way-Young, DPHD, provided the Board with fliers regarding a monthly First Aide and CPR Training and the Care Coordination Program; additionally, she discussed the Tire Drop Off Program success and stated the Radnor Township site collected 7 tons worth of tires.

### Fire Department Report:

A New York Fire Company is interested in purchasing Engine 431; will be sending a representative to Radnor after the holidays. The NY Company asked if a down payment was required to hold the engine; Trustee Weber motioned to hold Engine 431 until January 31, 2025 with a \$5,000.00 deposit, Trustee James seconded; all ayes, motion carries 2-0.

### Maintenance Department Report:

Trustee Weber presented the maintenance department report per Todd's notes: the AED signage has been placed at the township park. OTARMA grant signs have been received; the invoice for the signs will be submitted to OTARMA representative by FO Wheeland. The flags for pins in the cemetery have been placed. The Freightliner truck has a warning light on; Todd will take for maintenance later this week.

### Trustees Report:

Trustee James notified FO Wheeland that Five Star Cleaning has not received payment yet; the check was mailed out in the middle of November. FO Wheeland stated she would void original payment and reprint for Board to sign tonight. Trustee James stated the power washers have been acquired and he will assemble them after the holidays. He inquired regarding EMS training for the Fire Department; Firefighter Brad Belville and Steve Belville are both certified through Ohio Health and provide trainings to the department. The fire department is looking into procuring a new drug license.

Trustee Weber updated the Board on the repairs completed by Delaware County to the tile on Curren Road.

### Fiscal Officer Report:

The Board was presented with the Payment Listing for December 10-31 2024, with the addition of check #17218 for the amount of \$418.00 for Five Star Cleaning. Trustee James motioned to accept the Payment Register for December 10-31 2024; Trustee Weber seconded; all ayes, motion carries 2-0.


