The Radnor Township Board of Trustees met on Monday, December 9, 2024 at 6:30 PM at the Radnor Community Center.

Trustee Boysel called the meeting to order and led the Pledge of Allegiance.

Roll Call was taken as follows: Dan Boysel, aye, Dave Weber, aye, Cameron James, absent. Also present: Carrie Hacker and Joe Thrush, Todd Coonfare, RTFD employees Bob Fish, Shawn Kelly, Mike Foreman, Greg Butts, Ben Moder, Dorian Ross, and Steve Belville, and Fiscal Officer Katarina Wheeland.

Trustee Weber motioned to approve the November 25, 2024 meeting; Trustee Boysel seconded. All ayes, motion carries 2-0.

Community Report:

Carrie Hacker and Joe Thrush, representing Radnor Youth Athletic Association, inquired about funding for the township park's baseball field improvements; Trustee Boysel stated Radnor is working with Plan4Land on procuring grants. RYAA is now 501C and is working on fundraising.

Fire Department Report:

The Fire Department installed the new mailbox near the entrance drive.

The department has received inquiries regarding the sale of the old truck.

Spectrum ran cables from the road to the building; a 4th phone line will be utilized in the clerk's office.

Maintenance Department Report:

Todd ordered OTARMA grant signs; once the invoice is received, an invoice will be sent to OTARMA for reimbursement.

Todd mentioned Teresa Watkins purchased wreaths for memorial at the cemetery and Tim Harsh made wreath holders; all were kindly donated to the Township for use in the future.

Trustees Report:

Trustee Weber discussed ODOT enforcing no parking along SR 203 near Taylor St.; letters were mailed to homeowners in the area.

Trustee Weber notified the Board the 2025 Delaware County Road Improvement program paperwork was submitted. Additionally, Delaware County Engineer's office assessed the work needed on Curren Rd. and estimated the cost to be \$1,780.00 to fix the flooding issue. Trustee Weber motioned to approve the assessment and proceed with the work, Trustee Boysel seconded; all ayes, motion carries 2-0.

Trustee Boysel stated Mr. Riepenhoff is continuing to work on the records request made by NBC4 and will have a document for their request soon.

Fiscal Officer Report:


