Minutes of the Radnor Township Board of Trustees

The Radnor Township Board of Trustees met on Monday, February 5, 2024 at 6:30 PM at the Radnor Community Center.

Trustee Boysel called the meeting to order and Trustee James led the Pledge of Allegiance.

Roll Call was taken as follows: Dan Boysel, aye, Dave Weber, aye, Cameron James, aye. Also present, Jenifer Way-Young (Delaware Public Health District), RTFD Asst. Chief Fish, RTFD employees Dorian Ross and Greg Butts, Todd Coonfare, and Katarina Wheeland.

Trustee Weber motioned to approve the January 22, 2023 meeting minutes; Trustee James seconded. All ayes, motion carries 3-0.

Jenifer Way-Young provided the Board with information regarding a healthy living micro-grant available from the Delaware Public Health District; stating Delaware County has \$25,000.00 to divide amongst recipients to encourage a healthier community.

Assistant Chief Fish notified the Board that Peacock Water finished installing the new water softener and reverse osmosis system at the community center. Bob also provided the Board with a broad estimate of extending shift coverage for the fire department to cover the hours of 7:00 AM to 12:00 AM; stating all said for insurance, utilities, and payroll it would equal around \$435,000.00 a year to provide 16 hour a day coverage.

The Board discussed having two emergency monitoring companies provide the Township with quotes for monitoring the fire department and community center property.

Todd Coonfare apprised the Board on general matters for the Maintenance Department. Todd requested purchasing new flags for the Township and a fire-proof safe to store cemetery books.

The Board discussed selling the old truck located at the maintenance department; agreeing to have Trustee Weber and Todd put an ad in the newspaper asking for bids for the truck open to a specific date.

Trustee James provided the Board with two quotes for new doors for the community room and fire department; Trustee James motioned to accept the bid from DHPace for \$8,119.00, Trustee Weber seconded; all ayes, motion carries 3-0. The Board agreed to install wireless entry to the building at the fire department west door.

Trustee Weber notified the Board he received a quote from Mr. Griffith, who is working on building updates at the museum, for repairing the dugout roof for \$4,478.00 and residing the brown shed at the township park for \$5,522.00; Trustee Weber motioned to accept the bids, Trustee James seconded; all ayes, motion carries 3-0.

Trustee Weber also provided a quote from Mr. Griffith for repairing the downspouts at the community center for \$868.00 and motioned to accept the bid, Trustee Boysel seconded the quote; all ayes, motion carries 3-0.

Additionally, Trustee Weber motioned for the Board to fence in the area behind the maintenance building as long as costs are less than \$10,000.00; Trustee Boysel seconded the motion; all ayes, motion carries 3-0.

Trustee Boysel alerted the Board the personnel investigation in the Fire Department is still on track and Mr. Riepenhoff plans to have more information to the Board by their next meeting.

Trustee Boysel notified the Board he spoke to Mr. Guider regarding plotting the new cemetery lots and moving forward with the plan.


Finally, Trustee Boysel stated he plans to have the next Township Newsletter out around the end of February/beginning of March and he is working on getting the zoning committee up and running.

The Board was presented with Resolution #02-24, Annual Appropriations for year ending December 31, 2024; Trustee Weber motioned to accept Resolution #02-24, Trustee Boysel seconded; all ayes, motion carries 3-0.

The Board was presented with Payment Listing for February 1 to February 5, 2024; Trustee Weber motioned to accept the Payment Register for February 1-5, 2024 and Trustee James seconded; all ayes, motion carries 3-0.

The Board mentioned St. David's Day will be held on Saturday, March 2, 2024.




