The Radnor Township Board of Trustees met on Monday, July 22, 2024 at 8:00 AM at the Radnor Community Center.

Trustee Boysel called the meeting to order and Trustee James led the Pledge of Allegiance.

Roll Call was taken as follows: Dan Boysel, aye, Dave Weber, absent, Cameron James, aye. Also present: RTFD employees Bob Fish, Shawn Kelly, Ben Moder, Dorian Ross, and Steve Belville, and Fiscal Officer Katarina Wheeland

Trustee Boysel motioned to approve the July 8, 2024 meeting with no corrections; Trustee James seconded. All ayes, motion carries 2-0.

Fire Department Report:

The Board approved the purchase of a used snowblower for \$500.00 for the fire department to use during winter weather.

Discussion regarding Engine 431, which remains out of service at All American, continued with mention that the fire department would like the truck on location by August 5, 2024 as the trucks will all be undergoing hose testing.

The Board was presented with a list of new proposed new hires for the fire department. Trustee James motioned to hire everyone on the list pending background checks, Trustee Boysel seconded; all ayes, motion carries 2-0.

The fire department requested permission to dispose of a box of old pagers that have been stored in the Chief's office; Trustee Boysel motioned to throw the pagers away, Trustee James seconded; all ayes, motion carries 2-0.

Trustees Report:

Trustee James reported the new drinking water station is installed, however, Todd is locating a plumber to finish the installation and also check on the leak in the restrooms.

Trustee James mentioned Ann Jones stated the west doors of the historical museum are leaking at the bottom and he plans to purchase door seals on Amazon.com.

Trustee Boysel alerted the Board and Fiscal Officer to a records request from NBC4 regarding the fire department investigation and the lawyer's findings on the matter; the request has been forwarded on to Mr. Riepenhoff and Mr. Cavanaugh for review; Fiscal Officer Wheeland has replied to NBC4.

Trustee Boysel sought interest in a resolution supporting revising local government funds; the Board agreed the Township has no interest in the resolution.

Trustee Boysel looked into a cemetery grant for \$2,500.00; upon which he discovered the gross amount of work involved and decided the Board would not have enough time to fulfill the grant requirements before the July 31, 2024 deadline.

Trustee James motioned to approve the quote from Fishers to remove the dead tree from the cemetery, Trustee Boysel seconded; all ayes, motion carries 2-0.


Fiscal Officer Report:


Trustee Boysel moved to sell the old printer/copier on govdeals.com, Trustee James seconded; all ayes, motion carries 2-0.




