The Radnor Township Board of Trustees met on Monday, July 8, 2024 at 6:30 PM at the Radnor Community Center.

Trustee Weber called the meeting to order and led the Pledge of Allegiance.

Roll Call was taken as follows: Dan Boysel, absent, Dave Weber, aye, Cameron James, aye. Todd Coonfare, RTFD employees Bob Fish, Shawn Kelly, Greg Butts, Steve Belville, and Brad Belville.

Trustee Weber motioned to approve the June 24, 2024 meeting with no corrections; Trustee James seconded. All ayes, motion carries 2-0.

Fire Department Report:

Chief Fish reported that hose testing will be conducted on August 5, 2024. Fish informed the Board that 10 firefighters have been interviewed and that he is waiting to get back the background checks to move forward with the hiring process. Fish advised that one of the toilets in the women's bathroom is leaking and all of the toilets need re-caulked around the toilets along with new toilet seats. Still waiting to hear from Mr. Cavanaugh on the guidance moving forward with Rosenbauer. The fire department is still waiting on the generator project to move forward.

Assistant Chief Kelly stated that the front sign for the fire department and community center need to be fixed based on the wood rotting away. It was also mentioned that the mailbox is leaking from being struck. Options will be looked at for moving the mailbox or moving the mail to a Radnor post box.

Trustees Report:

Trustee Weber advised if Todd could trim the arborvitae bushes in the cemetery so they would not overgrow where vehicles would have a hard time getting through, which Todd said he would trim them. Weber motioned to switch from PNC Bank to Richwood Banking Company. Trustee James seconded, motion carries 2-0.

Trustee James motioned to have Trustee Weber be the liaison and approve the resolution (Resolution #05-24) to grant authority to negotiate the term of a real estate transaction for Radnor Township in Delaware County. Trustee Weber seconded, motion carries 2-0.




The Board signed the June 2024 Bank Reconciliation.
