The Radnor Township Board of Trustees met on Monday, November 11, 2024 at 6:30 PM at the Radnor Community Center.

Trustee Boysel called the meeting to order and Trustee Weber led the Pledge of Allegiance. A moment of silence was given in honor of Veteran's Day.

Roll Call was taken as follows: Dan Boysel, aye, Dave Weber, aye, Cameron James, aye. Also present: Amanda and Ryan Rhodes (residents), Dwight Wells (resident), Pam Zeirott (Radnor Heritage Society), RTFD employees Bob Fish, Shawn Kelly, Ben Moder, Greg Butts, Jordan Long and Steve Belville, and Fiscal Officer Katarina Wheeland.

Trustee Weber motioned to approve the October 28, 2024 meeting; Trustee Boysel seconded. All ayes, motion carries 3-0.

Community Report:

Amanda and Ryan Rhodes, residents on Curtis Rd., inquired about the property that was just demolished; the Board requested a quote for the Rhodes to mow the property as it is connected to a small parcel of their land they currently maintain.

Pam Zeirott, Radnor Heritage Society, presented the Board with an update regarding Wreaths Across America which will be placing wreaths at the Radnor Cemetery on December 14, 2024. Her goal is to obtain 400 wreaths for the cemetery; current wreaths purchased and donated is 320. Pam mentioned she has many volunteers arranged for the day to place the wreaths at the designated gravesites. Additionally, Pam has been working on compiling a map of the cemetery and shared her progress with the Board.

Dwight Wells, resident on Curren Rd., requested an update regarding the tile that needs to be redone as it is flooding his property. Dwight provided the Board with images and stated he contacted the Township in April regarding the issue and nothing has been done since. Trustee Weber stated he has contacted the contractor who typically does tile work for the Township; he is booked but has Curren Rd. on his list. Additionally, Trustee Weber has reached out to other contractors who are also unavailable; he said he would put pressure on the contractor to get the work completed as soon as possible.

Fire Department Report:

The Fire Department listed Engine 431 on a third-party website for sale. The new truck the department is hoping to purchase will be discussed in Executive Session.

Trustees Report:

Trustee James provided the Board with 2 options and quotes for power washer units; the 2000 PSI is \$3,600.00 and the 3000 PSI is \$6,050.00; the fire department and other board members were interested in obtaining quotes for gas powered power washers. Trustee James will contact Richwood AgPro for additional quotes.

Trustee Weber contacted ODOT regarding parking on 203 near Taylor St.

Trustee Boysel marked the placement for the trees being donated to the Township by Consolidated Co-Op; the trees are scheduled to be delivered and planted on November 14th at 2:00 PM.

Trustee Boysel spoke to Alex at the Delaware EMA office regarding the BRIC grant; stated it is not worth waiting until next summer to purchase the generator as there is no guarantee the grant would be awarded to the Township. Trustee Boysel motioned to move forward with the purchase of the generator previously quoted by Wenig's; Trustee Weber seconded. All ayes, motion carries 3-0.

Fiscal Officer Report:

The Board was presented with the Payment Listing for November 1-11 2024. Trustee James motioned to accept the Payment Register for November 1-11 2024; Trustee Weber seconded; all ayes, motion carries 3-0.


The Board signed the October 2024 Bank Reconciliation.
