## Minutes of the Radnor Township Board of Trustees

February 24, 2025

### Call to Order and Roll Call

The Radnor Township Board of Trustees met in regular session on Monday, February 24, 2025 at 6:30 PM at the Radnor Township Community Center, 4061 State Route 203, Radnor, Ohio. Chairperson Boysel called the meeting to order and the roll was called; attending were Trustees Dan Boysel, Dave Weber, and Cameron James.

### Approval of Minutes

Mr. James moved and Mr. Weber seconded to approve the minutes of the February 10, 2025 meeting. Vote: Boysel, aye; Weber, aye; James, aye. Motion passed.

### Old Business

- The Board reviewed the proposal for Buckeye Valley Local School District to purchase Township property located at 4230 State Route 203, Radnor, Ohio and listened to additional public comment regarding the proposed sale. Trustee James moved and Trustee Boysel seconded for a vote of the Board on accepting the proposal from Buckeye Valley Local School District. Vote: Boysel, nay; Weber, recused from voting; James, nay. Motion failed.
- The Board discussed the \$160,000 grant the township was awarded; Trustee Boysel spoke of getting the paperwork ready to accept the grant. The Board notified the public in attendance that the township has no extra funds for the park and requested township residents and baseball parents assist in improvements. Funds for park improvements may possibly come from other grants, donations, a specific park levy and from resident assistance.

### Public Input

- Jenifer Way-Young, Delaware Public Health District, provided the Board with fliers regarding solid waste drop off. The Board discussed Resolution #02-25, a Resolution to Approve the Delaware, Knox, Marion, Morrow Joint Solid Waste Management District's Solid Waste Management Plan Five Year Update. Trustee Weber moved and Trustee James seconded to approve Resolution #02-25. Vote: Boysel, aye; Weber, aye; James, aye. Motion passed.
- The Radnor Township Heritage Society will hold their annual Saint David's Day lunch on Saturday, March 1, 2025.

### Fire Department

- Engine 431 was sent for maintenance/repairs prior to selling truck; it is all set to go. The contract for the NY Fire Department is currently at the Delaware County Prosecutor's Office for review.
- The new fire truck is estimated to be ready mid to late March.
- Winig's will be working on installing the generator for the fire station and community room; they are still waiting on the transfer switch to finish the work.
- A policy to enable a night shift is in the works and will be brought to the Board when completed.

### Road/Maintenance Department

- Trustee Weber discussed the chip seal quote/contract from Small's instead of doing chip seal through the county; the Board decided to wait to finalize plans until Doug Riedel from the Delaware County Engineer's Office can attend a township meeting.

## Board Report

- Trustee James investigated a breaker issue at the cemetery lych gate and hero's memorial; plans to seek quotes to repair breaker.
- Trustee Weber discussed the benefits of purchasing a gravel bin attachment for a Township truck in order to berm roads; the cost is approximately \$9,000.00. The Board stated it is something to think about.
- Trustee Boysel notified the Board, and attending residents, Consolidated Electric was awarded a grant to provide fiber in rural townships; Radnor Township is included in the scope and a road list will be provided soon.

## Financials/Fiscal Officer

- Mr. Weber moved and Mr. Boysel seconded to approve pending warrants detailed in payment listing detail report for February 11, 2025 through February 24, 2025.

## New Business

- Trustee Boysel moved and Trustee Weber seconded the Addendum No. 1 to Energy Consulting and Management Agreement with Trebel. Vote: Boysel, aye; Weber, aye; James, aye. Motion passed and agreement signed.
- Trustee Weber moved and Trustee Boysel seconded Resolution #03-25, In the Matter of Opposing the Ohio's EPA Proposed Facility Planning Area Maps for Delaware County. Vote: Boysel, aye; Weber, aye; James, aye. Motion passed.

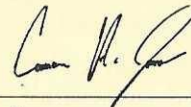
