Call to Order and Roll Call

The Radnor Township Board of Trustees met in regular session on Monday, March 24, 2025 at 8:00 AM at the Radnor Township Community Center, 4061 State Route 203, Radnor, Ohio. Chairperson Boysel called the meeting to order and the roll was called; attending were Trustees Dan Boysel and Dave Weber.

Approval of Minutes
