The Radnor Township Board of Trustees met on Tuesday, December 31, 2019 at 9:00 AM at the Radnor Community Center.

Those present were Dan Boysel, Teresa Watkins, Dave Weber, Doug Riedel from the Delaware County Engineer's Office, Katarina Wheeland, Todd Coonfare and John Coonfare.

Dan called the meeting to order and led the Pledge of Allegiance.

Minutes of the December 9, 2019 meeting were read. Dan moved to approve the December 9, 2019 meeting minutes and Dave seconded.

Mr. Riedel updated the Board of Trustees on the Byers Road Request for Engineering Assistance concerning drainage issues in the area of 4120 and 4130 Byers Road. The county findings indicate that two (2) new driveway pipes are required at the addresses noted. Mr. Riedel suggested a possible cost sharing resolution with the residents affected. Dave moved to have Miley Excavating provide cost estimates for the two (2) new driveway pipes at 4120 and 4130 Byers Road and Teresa seconded. All ayes.

Mr. Riedel advised the Board of Trustees that the results of the Ohio Public Works Commission Issue II Grant Application for River Road should be known in January.

Todd advised the Board of Trustees that Sellers Electric would be commencing work on the fuel tank at the community center and lighting at the park flagpole next week.

Todd reported that the two (2) new front tires for the John Deere tractor would be \$500.00 each from Parrott Implement.

Todd advised the Board of Trustees that the new updated curve signs had been installed on Hills Miller Road. Todd completed both Radnor and the Troy Township portion of the sign installation. The material cost related to Troy Township's portion of the signs was \$160.95 and they will be invoiced for the material used on their portion of the road. Dan stated that he had received a complaint from a Troy Township resident about the location of the signs near their property. He refereed the resident to the Troy Township Board of Trustees.


Teresa reported that she would be attending the upcoming Ohio Township Association Winter Conference.
